NAESB WGQ Business Practice Standards Course - Version 3.1 February 21, 2019 – Houston, TX

As you may know, the Federal Energy Regulatory Commission (Commission) has revised its regulations to incorporate by reference, with certain exceptions, Version 3.1 of the NAESB Wholesale Gas Quadrant (WGQ) standards. This action was taken by the Commission through Order No. 587-Y, issued on November 15, 2018 in Docket No. RM96-1-041, and requires that interstate natural gas pipelines file tariff records to reflect the changes with the Commission by April 1, 2019. To support industry implementation of these standards, NAESB is offering the NAESB WGQ Business Practice Standards Version 3.1 Course. The course is designed to provide a comprehensive overview of the NAESB WGQ standards with specific focus on the updates and changes made in Version 3.1 of the standards. The course will include:

- An overview of NAESB as an organization and its 25-year relationship with the industry and the Commission
- An overview of the American National Standards Institute (ANSI) accredited standards development process employed by NAESB since its inception
- An overview of Version 3.1 of the NAESB WGQ Business Practice Standards, including a review of all standards changes and updates that were made to the current version of standards
