Dear GISB Contracts Subcommittee Drafting Team Participants,

This is the fifth meeting of the drafting team of the Contracts Subcommittee (see attached list). The first meeting was held on May 21 to May 23 in Houston and the second meeting was held on June 6 and the third meeting was held on June 12 and the fourth meeting was held on June 25. There is no agenda for the meeting, nor will minutes be taken. The work product of this group will be the revised base contract for short term sales and purchases of natural gas. The group has a very specific charge to take the concepts supported by the Contracts Subcommittee for changes to the short term base contract and provide language for those concepts in the contract.

For this meeting, the drafting team will:

Review contract with drafting language

(note the following words for consistency in use: defaulting party, contract, transaction confirmation, liquidation event)

Is the use of the language "Section 10 Event of Default" or "Event of Default" a question that this group can answer instead of sending this question back to the subcommittee?

New issues or debates over existing issues for which the subcommittee has already determined a conceptual response should be addressed by the whole subcommittee. Once the drafting team has completed the language changes to the base contract, the revised contract will go through a final review by the entire subcommittee and a vote before it is sent out for industry comment.

GISB thanks the volunteers on the drafting team for providing language to support the agreed upon -- membership driven organizations such as GISB are successful because of the efforts of such volunteers.
