There is a lot of construction on PGA Boulevard (the main road connecting to I-95 and the major hotels like the Doubletree and Marriott) and the traffic is very congested. FPL is recommending that participants stay on relatively uncongested, tropical Singer Island, in Jupiter, or in one of the other smaller hotels nearby.

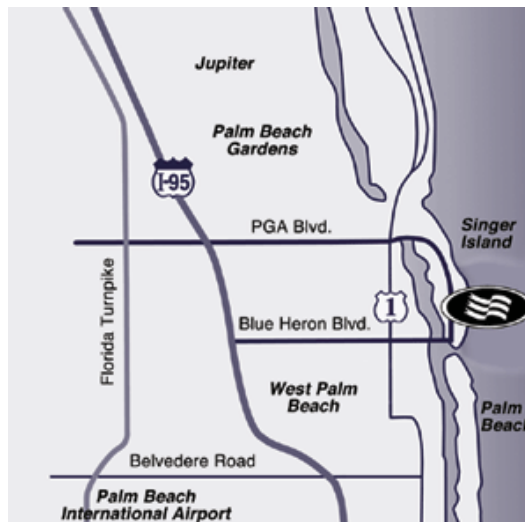
## HOTEL ACCOMMODATIONS

### DIRECTIONS to the CROWNE PLAZA OCEANFRONT

From the Palm Beach International Airport: Take I-95 North to Blue Heron Boulevard,  
Go East crossing over the Intracoastal Bridge, Travel ½ mile North to hotel on beach side.



### DIRECTIONS to FPL'S JUNO BEACH OFFICES from CROWNE PLAZA

Exit from Crowne Plaza turning right onto North Ocean Drive (which curves into PGA Blvd).  
Travel North, curving West onto PGA Blvd. Turn right from PGA Blvd onto US#1 going North.  
Turn left onto Universe Boulevard at the traffic light & then take next right into FPL's parking lot.  
Enter though Building A (building straight ahead as you enter FPL's property & closest to US#1).
