1. Administrative

Mr. Eynon opened the meeting. Introductions were made. Ms. McMillan gave the antitrust advice. Mr. Eynon suggested adding a discussion of the Glossary Subcommittee mission statements to the agenda. Ms. Camp moved, seconded by Mr. Eynon to adopt the agenda as modified. The agenda was adopted as modified absent objection. Mr. Eynon provided changes to the draft minutes of August 29, 2003. Ms. Camp moved, seconded by Ms. Robert to adopt the August 29, 2003 draft minutes as modified. The minutes were adopted as modified absent objection. Mr. Eynon nominated himself to the position of co-chair for the REQ Glossary Subcommittee. Mr. Eynon was elected co-chair of the REQ Glossary Subcommittee absent objection.

2. Discussion of REQ/RGQ Glossary Subcommittee Mission Statements

Mr. Eynon offered comments regarding the mission statements and after a brief discussion, participants agreed to defer any official discussion of these documents until the next Glossary meeting. Mr. Eynon noted there is also a draft of the Glossary Subcommittee procedures for adopting and changing definitions that will be discussed at the next meeting.

3. Discuss and Vote on Definitions

Market Participant

A party engaged in the process of providing competitive retail energy to end-use customers including but not limited to the Distribution Company, the Supplier, the Registration Agent, the settlement agent, and the meter reading entity.

Participants discussed the definition for Market Participants, noting the changes detailed above. Ms. Robert moved, seconded by Ms. Camp to accept the definition as modified. The definition was accepted as modified absent objection.

Registration Agent

An entity facilitating switches and performing record keeping for a specified geographical area.

Participants discussed the definition for Registration Agent. No changes were suggested to the definition. Ms. Camp moved, seconded by Ms. Robert to accept the definition as stated. The definition was accepted as written.

Ms. Camp noted there were two other terms mentioned at the last Customer Processes and Supplier-Utility Interface subcommittee meetings during which changes were suggested to previously adopted definitions. Participants decided that because the changes were not substantial
