1. Welcome

Mr. Newbold opened the meeting and gave the antitrust guidelines. The agenda was adopted as drafted. The draft minutes from February 25, 2003 were adopted with modifications.

2. Joint REQ/RGQ EC, REQ EC actions of 2/19

Mr. Newbold stated that during the February 19, 2003 joint REQ/RGQ EC meeting the coordination of the RGQ and REQ subcommittees was discussed. He noted the consensus of the two ECs was that the RGQ and REQ SUIS subcommittees will work together. Mr. Newbold stated that the REQ EC established the Glossary Subcommittee in order to ensure consistency in definitions.

3. Review of REQ SUIS Process to Date

Using a power point presentation, Mr. Newbold reviewed the progress of the REQ SUIS. The presentation is posted on the NAESB web site as a work paper for this meeting.

4. Review of Creditworthiness Document

The SUIS subcommittees reviewed the document and accepted suggestions from participants for changes, deletions, additions, etc. The RGQ SUIS participants were encouraged to make contributions and offer opinions on the content of the draft Creditworthiness document. 5. Next Steps
