## Supplier Licensing Requirements

### Registration with LDC

The Maryland Public Service Commission ("Commission") licensed supplier must also register and complete application agreement with the LDC.

All suppliers must be licensed by the Commission to participate in choice programs. The Application requests the supplier provide a significant amount of information, which include business information, technical fitness and financial integrity information. Applicant must also provide information on their scope of operations and deposit or prepayment requirements.
