All,

Today the Standards Review Subcommittee completed its review of a request made by the Joint ESS/ITS and BPS as documented in its March 28, 2008 Meeting Minutes. The meeting minutes stated:

Mr. Saini and Mr. Skiba agreed that the SRS should review the FAC standards discussed in paragraph 150 of Order 890-A to determine if complementary business practices should be developed. This action item was recorded in the concept document.

NERC provided the SRS with a list of FAC standards that are under development. (See attached document.) Based the input the SRS has received from NERC, the SRS determined no additional NAESB business practices need to be developed to complement the FAC standards in support of Orders 890 and 890-A.

I suspect this reference was purely related to MOD-001 through -009 and FAC-012 and -013 - but I looked at the other work we have ongoing, and I don't think NAESB needs to do anything at this time. See below

Project 2008-04 Facility Ratings Order 705 - This is about SOLs. FAC-014 deals with communicating SOLs - NAESB might want to make the posting of SOLs required, but I don't think it is necessary. Plus, there may be critical infrastructure issues about making this information available -

Project 2006-09 Facility Ratings - This is about actual equipment ratings, so I don;t think you would care to do anything with it. Plus, there may be critical infrastructure issues about making this information available -

Project 2007-07 Vegetation Management - Obviously not needed on OASIS

Project 2009-02 Connecting New Facilities to the Grid - Hasn't been started yet, but when we do, we may want to have requirements that this info be posted on OASIS.

Andy,

Narinder and I ended up with the following action item from a March 28th Joint BPS ESS/ITS meeting that needs some input from you. Below is the extract from a concepts document, which was discussed during the meeting. I've **bolded** the action item Narinder and I, as co-chairs of the SRS, have to review the FAC standards.

Paragraph 150 in Order 890-A states *"We deny as premature Constellation's request to require OASIS postings of additional model benchmarking and forecasting data/TSR study audit data. Such information would be utilized in the process of updating and benchmarking models to actual events, which is the subject of ongoing efforts to modify relevant reliability standards from the MOD and facilities design, connections and maintenance (FAC) groups."*

Status: No NAESB business requirements are required for the paragraph listed above. Upon completion of the NERC MOD the co-chairs of the ESS/ITS and BPS will determine if any additional work is required by the subcommittee.

The SRS Co-Chairs have confirmed that the SRS would review activity on the FAC standards to determine if complementary NAESB business practices should be developed per the SRS Scope of Work.

Here's the question for you. Are there any other changes to the FAC standards in support of Orders 890, and 890A other than the ones associated to the supplemental SAR NERC: Revisions to Existing Standards MOD001-MOD009, FAC12-13? If not, I don't think there is anything else that Narinder and I have to do with the reviewing the FAC standards based on the May 1st NERC/NAESB meeting minutes. If there are other FAC standards that are being modified in to support Orders 890, and 890A, can you provide us a list of those FAC standards that are being modified?
