RE: Frequently Asked Questions on Participation in NAESB Standards Development Subcommittees and Use of the NAESB Web Site

June 3 Changes to the Web Site and Changes for Non-Member Participation in Standards Development Subcommittees and Task Forces

Changes to the NAESB web site to delineate member from non-member access are in effect as of June 3, 2013. For non-members, there is an automated response to indicate attendance at NAESB meetings, for which a fee will be charged. We expect the changes to go into effect on Monday, June 3, 2013.

For members on June 3, nothing will look different when you access the web site, except that you may need to have handy your NAESB User ID and passcode. You will log in at the upper right-hand corner of the NAESB home page, where you will be asked for your NAESB User ID and pass code (See Figure 1, page 4). If you do not remember your NAESB User ID and passcode, give our office a call (713-356-0060). If you are not sure that your membership is current, a quick call to the office or checking our membership list should provide you with the needed information, (<http://www.naesb.org/pdf4/memstats.pdf>). Remember, if you are an employee of a regulatory agency, you can request membership from NAESB at no fee. Membership forms can be found at <http://www.naesb.org/pdf4/naesbapp.pdf>.

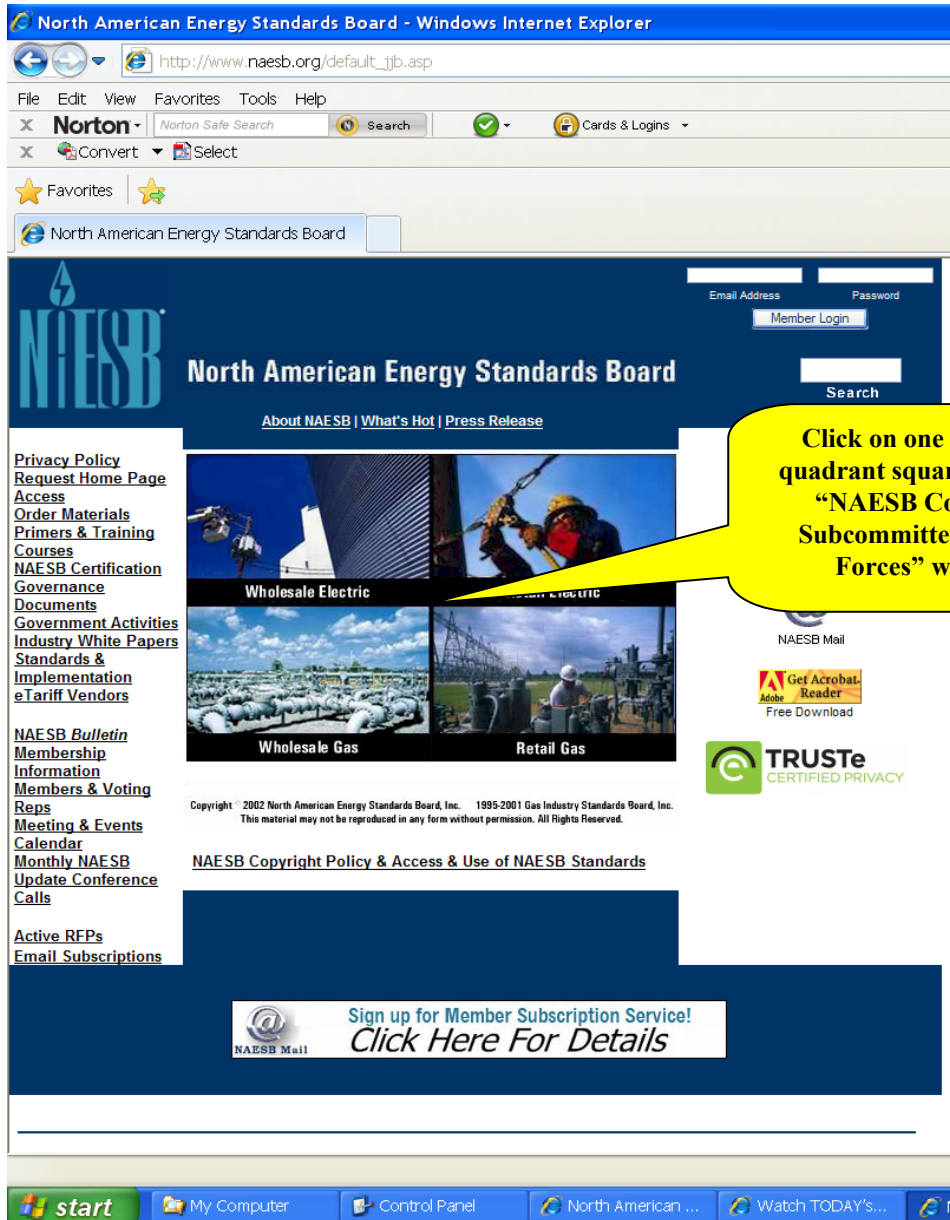




Figure 3: “NAESB Committee, Subcommittee and Task Forces” web page

For our participants who are non-members, there are differences. As you access one of the four quadrant squares – wholesale electric, retail electric, wholesale gas and retail gas, you are directed to the “NAESB Non-member Access: NAESB Committees, Subcommittees and Task Forces” web page, (See Figure 2, page 5). This web page contains a list of links including quadrant work products available and a link to the “NAESB Current Committee Activities” web page, (See Figure 3, page 6). The “NAESB Current Committee Activities” web page provides a table sorted by date, and includes all meetings scheduled for the immediate past 30 days, the current day, and the upcoming 30 days and the meeting materials for those meetings.

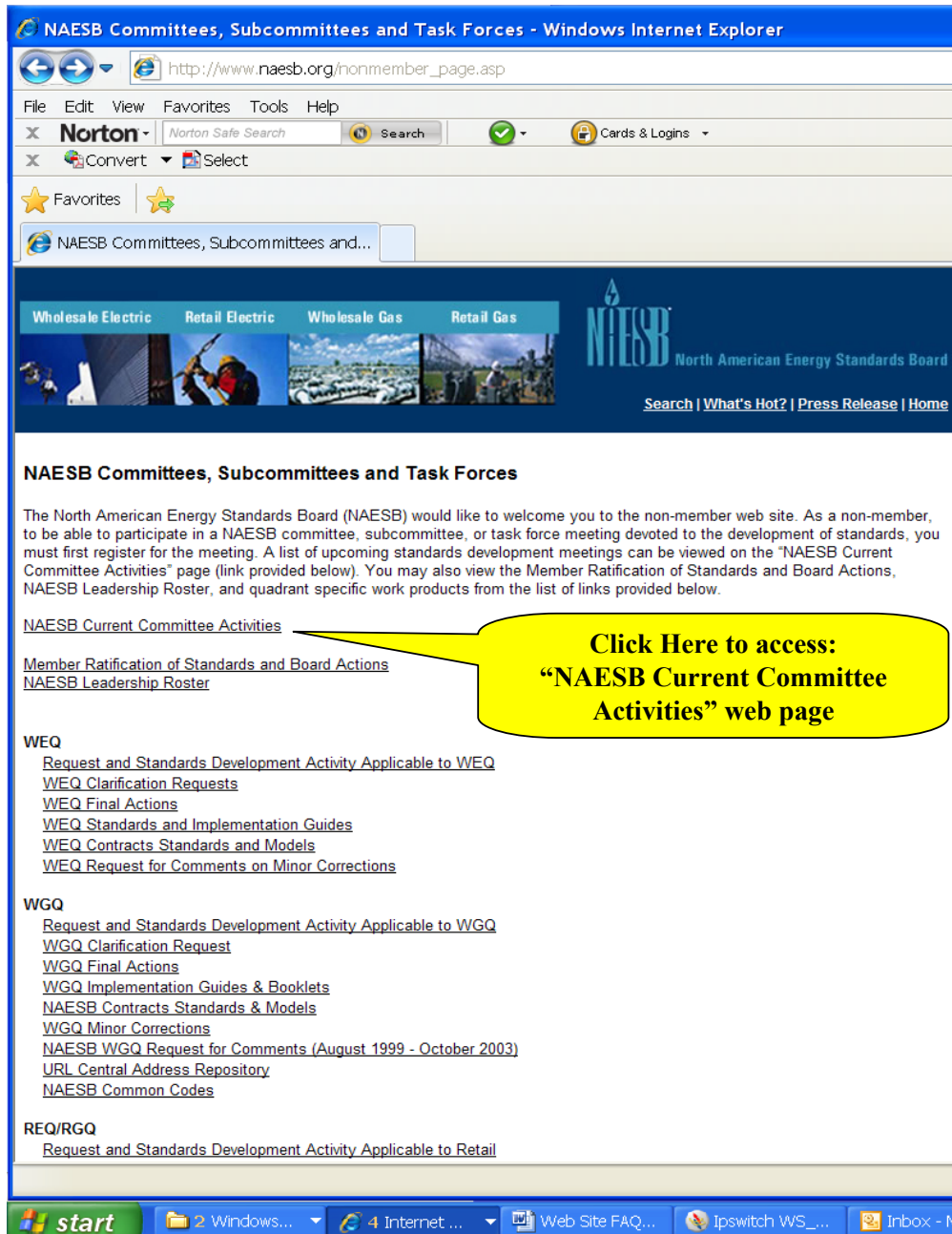




Figure 4: Fee Structure and Registration Process

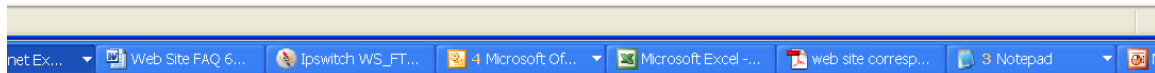
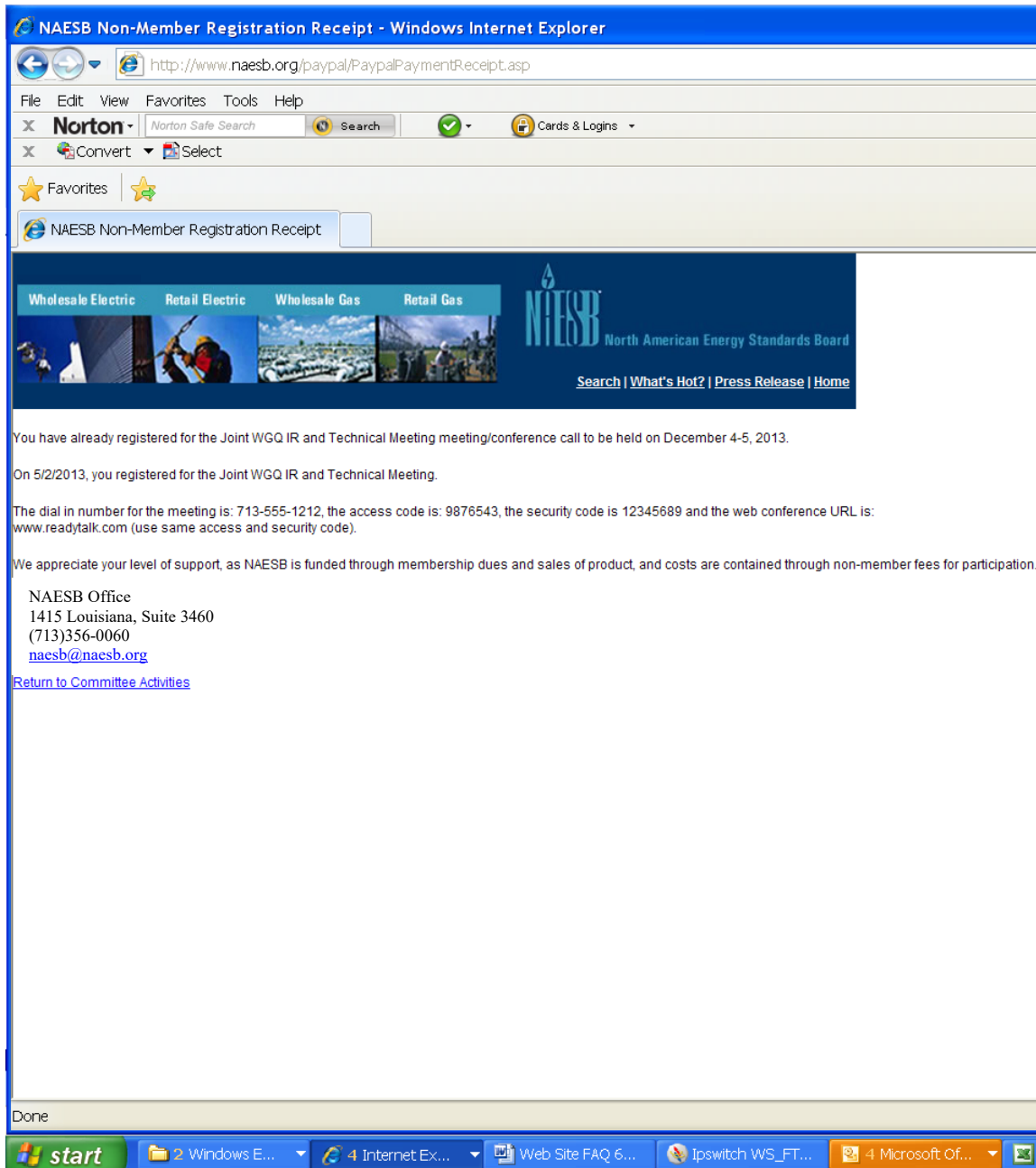




Figure 9: If you have already registered, immediate notification will be displayed on the web page and payment will not be processed.

Also for our non-member participants who attend standards development subcommittee or task force meetings either in person or by phone/web cast, there will be a fee charged for attendance. The fee structure is outlined on the web site at the top of the “NAESB Current Committee Activities” page, (See Figure 4, page 7). On this web page, for the subcommittee or task force meetings or conference calls that are specific to standards development efforts, the non-member can access the “non-member RSVP” link for the meeting or group that is of interest and, in doing so, (See Figure 5, page 8) will be directed to a web page, “NAESB Non-Member Committee Registration,” for payment information, (See Figure 6, page 9). The information the non-member provides can be for a single meeting or for a full year of meetings. Once submitted (See Figure 7, page 10), an email confirmation is provided to the non-member including an immediate confirmation on the “NAESB Non-Member Committee Registration” web page, (See Figure 8, page 11). If you have already registered, an immediate notification will be displayed and payment will not be processed, (See Figure 9, page 12). Once registered, all access information is provided by email, (See Figure 10, page 13). For meetings that do not have a “Non-member RSVP” link, there is no fee to attend. The agenda and meeting materials for the meeting of interest is accessed from the “NAESB Committee Activities” web page.



Questions and Answers on Web Site Changes and Changes for Non-Member Participation in Standards Development Subcommittees and Task Forces

- Question: (1) As a chair of a NAESB standards development task force or subcommittee, what changes will I need to prepare for?
- Response: The NAESB Office will review attendance records to determine if the participants who are not members have provided the fee to participate. If they have not, the NAESB Office will contact their company. This will also be true if a member participates in a meeting and represents a quadrant and segment in which they do not have membership. Members can attend any meeting, but if they choose to represent a quadrant and segment in which they do not hold membership, then the meeting fee will apply to them. The NAESB chair of the subcommittee or task force will not be asked to perform any monitoring tasks for membership.
- Question: (2) As a member of a specific quadrant and segment – can I attend all meetings at no charge?
- Response: Members can attend any meeting for no fee as part of their membership benefits. Should a member choose to represent a quadrant and segment in which they do not hold membership, then the meeting fee will apply to them.
- Question: (3) As a member of a specific quadrant and segment – can my affiliates attend all meetings at no charge?
- Response: Affiliates are welcome to all NAESB meetings as they are open to any interested party. Affiliates are not members, and as such, the meeting fee will apply to them. Affiliates will also have access to the non-member portion of the NAESB web site, not the member portion of the NAESB web site. Affiliate status as a non-member has not changed since the inception of GISB and NAESB.
- Question: (4) As an attorney or consultant representing a member of a specific quadrant and segment – can I attend all meetings at no charge?
- Response: If you are solely representing a member of NAESB in that member’s quadrant and segment membership, declare such on the sign-in sheets for the meeting, vote representing the member company in that member’s quadrant and segment, then the meeting fee will not apply to you.
- Question: (4) Will access to protected documents change?
- Response: The access to protected documents will not change. If the documents are protected because they include existing standards text, they will remain protected. If, as a non-member, you need access to the protected document, you should contact the NAESB Office and access may be granted through File Open, a software tool for document access and protection.

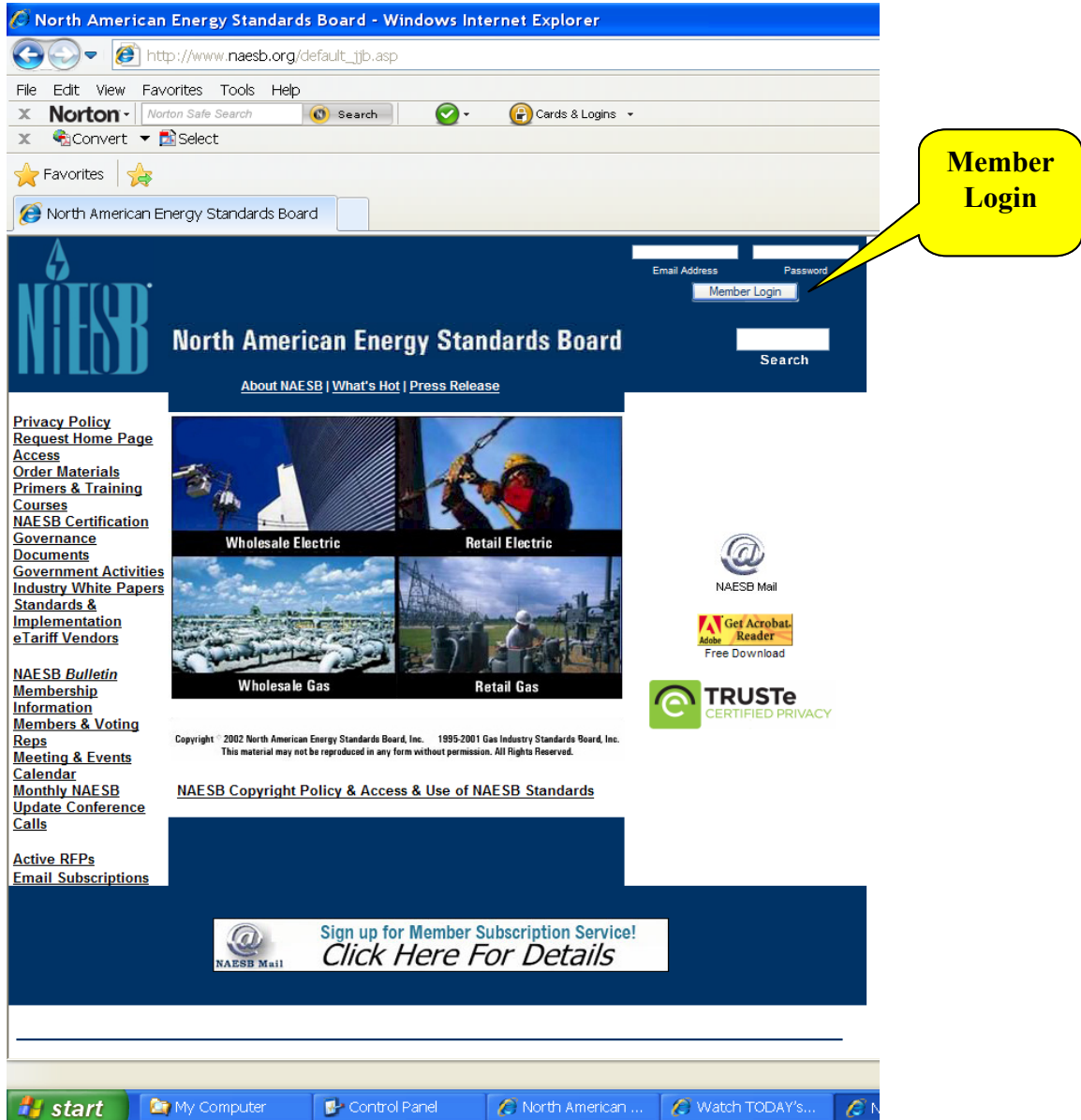

- Question: (5) As a non-member, how do I have access to meeting materials that are more than 30-days old?
- Response: Should you need a document from a meeting that occurred more than 30 days since your request, you should call the NAESB Office. The library of documents for meetings that occurred more than one month prior is maintained on the NAESB web site for members.
- Question: (6) As a non-member, is the format of the meeting materials different from the format that members see?
- Response: No. The format will be the same, and is typically provided in editable format for ease of use.
- Question: (7) As a non-member, can I request access to information that is on the members-only portion of the NAESB web site?
- Response: Should you need a document from a meeting that occurred more than 30 days since your request, you should call the NAESB Office. The library of documents for meetings that occurred more than one month prior is maintained on the NAESB web site for members.
- Question: (8) As a non-member, can I request access to information that contains standards language and is protected?
- Response: The access to protected documents will not change. If the documents are protected because they include existing standards text, they will remain protected. If as a non-member, you need access to the protected document, you should contact the NAESB Office and access may be granted through File Open, a software tool for document access and protection.
- Question: (9) As a non-member, if I have chosen to participate in a subcommittee for a twelve consecutive month period, is my fee transferrable to another individual in my company?
- Response: Meeting attendance fees are not transferrable.
- Question: (10) As a non-member, if I have chosen to participate in a subcommittee meeting and have paid the meeting fee, and then tried to register for the same meeting again, will I be charged again?
- Response: No. If you try to re-register, you will receive a message that you are already registered. Should you have any questions on this process, please call the NAESB Office.

Figure 2: Access to “NAESB Committee, Subcommittee and Task Forces” web page

NAESB Current Committee Activities

Welcome to the "NAESB Current Committee Activities" web page. Below, you will find a table, sorted by date, which includes all meetings scheduled for the immediate past 30 days, the current day, and the upcoming 30 days.

For individual non-members wishing to participate in a standards development meeting, either by phone or in person, the meeting participation fee is \$250 for individual meetings/conference calls. As an alternative, individual non-members may pay an annual (12 consecutive months) subcommittee/task force fee of \$2000 (specific to a single subcommittee/task force) in lieu of the non-member individual meeting participation fee. The annual subcommittee/task force fee will allow an individual non-member to participate in the single subcommittee/task force meetings/conference calls for a period of 12 consecutive months.

To register, access the "non-member RSVP" link for the meeting or group that is of interest located in the first column of the table below. The link will direct you to the "NAESB Non-Member Committee Registration" web page for payment information. Complete ALL fields in the registration form. After entering the "Billing Address", select the appropriate non-member meeting participation fee from the drop-down menu:

- \$250 for individual meetings/conference calls
- \$2000 for individual non-member annual (12 consecutive months) single subcommittee/task access

Once all fields in the registration form have been completed and submitted, an immediate confirmation will appear on the "NAESB Non-Member Committee Registration" page followed by an email confirmation. The agenda and meeting materials for the meeting of interest is accessed from the "NAESB Committee Activities" page.

Please note for those meetings/conference calls that do not have a "Non-member RSVP" link, there is no fee to attend.

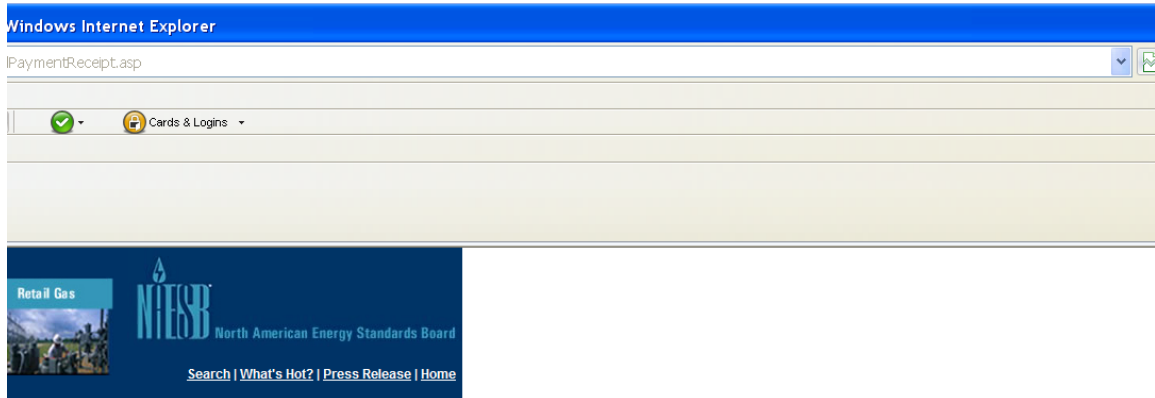
