

# RECOMMENDATION TO GISB EXECUTIVE COMMITTEE

Request #: 97028

The Market Settlement Task Force of the GISB Information Requirements Committee recommends that the conditionality of Receipt Location and Delivery Location data elements on the Invoice Data Set should be based upon Location Indicator rather than Service Code.

## Abstract / Discussion (E-1, E-3, E-4):

Depending upon the charge being invoiced for a particular Service Code, location information may or may not be needed. So when basing the delivery and receipt location data element on Service Code the need for the data elements becomes either yes, no, or sometimes. Since data rules should be based on sometimes conditions, the conditionality should be based on another data element

The Location Indicator data element specifies whether or not per unit charges are applied to the receipt or delivery volume. Location Indicator values include Receipt point only, Receipt point and delivery point, ..., No point or zone information. This data element was designed to provide users of the invoice, information on what data elements should be included in the transaction set.
