3. Description of Proposed Standard or Enhancement:

The Payment Remittance data set (3.4.2.) needs an additional data element to indicate the party being paid. (There are three data elements refering to the party making payment but none stating who is to receive the payment.)

[Note: There is a similar request for clarification. If the clarification resolves this issue, then this request will be withdrawn.]

4. Use of Proposed Standard or Enhancement (include how the standard will be used, documentation on the description of the proposed standard, any existing documentation of the proposed standard, and required communication protocols):

Identify the party to receive the payment. Since there will be 3rd Party software providers as well as pipeline computer systems that accommodate multiple service providers, it is necessary to be able to determine the party being paid. Without this data element, there is the potential of the payment remittance being forwarded to the wrong party or the remittance being forwarded to no one since the recipient is unknown.

The payment remittance will be able to reach the intended party.
