For informational purposes, the REQ of NAESB is providing survey results which gathered names of potential candidates for election to the Board and the EC. Each segment has four open seats for the Board and four open seats for the EC. Attached is a list of names of the potential candidates by segment and listed below is a tally by segment as of May 10, 2002.

Board of Directors:

- Suppliers – 4 candidates
- Services – 5 candidates
- End Users – 1 candidate
- Distributors – 5 candidates

Executive Committee:

- Suppliers – 5 candidates
- Services – 3 candidates
- End Users – 2 candidates
- Distributors – 12 candidates

All candidates for the REQ of NAESB who are interested in being considered for the open seats must provide the NAESB office with their name, company, segment identification, whether they are a candidate for the Board or the EC and a biography. An individual may only declare for either the Board or the EC. This information must be received by the NAESB office by the end of business on May 21, 2002. The NAESB office has already received this information from several candidates. To be eligible, a candidate must be a NAESB member in the segment and in good standing. On May 22, 2002, a ballot with biographies of the candidates will be sent to NAESB REQ members in good standing. The election period will close June 5, 2002, after which the new Board and EC members will be announced.
